You, and Each of You Are Hereby Notified, that on the 8<sup>th</sup> day of April, 2022, the above named petitioner Jason Fisher and others, filed a petition to construct, reconstruct, widen, repair, replace, clean, locate, enlarge and maintain existing open ditch and storm sewer with the Commissioners Clerk of the County, the substance and prayer of which said petition is, that the construction of the improvement is necessary, will benefit the petitioner(s), and will be conducive to the public welfare, and prays for the making of such improvement. All costs of engineering, construction, and future maintenance will be assessed to the benefiting parcels of land as described in Section 6131 of the Ohio Revised Code. The exact size and location of the tile will be determined at the time of the engineering survey and design between the first and second hearing.

An owner may file, not more than 21 days after the date of the view, an amendment to the petition that expands the length of the proposed improvement, provided that such amendment does not expand the area to be benefited by the proposed improvement.

An owner receiving this notice may comment on the proposed improvement in writing before or in person at the public hearing on the petition.

Amendments, written comments on the proposed amendment or comments on the petition can be submitted to the Hancock County Engineer, Attn: Kyle Parker, 1900 Lima Avenue, Findlay, OH 45840.

As it is claimed that the improvement will affect property owned by you, and you are an owner named in the petition and legal record on the date of its filing, you are hereby notified that the Board of County Commissioners of said County has fixed the 14<sup>th</sup> day of June, 2022, at one o'clock p.m. at the intersection of Wolf Run and Shawnee Drive, Findlay, Ohio, as the time for the view thereon and also the 16<sup>th</sup> day of August, 2022, at six o'clock p.m., at the Brugeman Lodge at Riverbend Park, 9250 Township Road 208, Findlay, Ohio as the time and place, for the first hearing on the petition.
