Resolution #179-17 - Transfer of funds within the appropriation - Probate Court. Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

The Commissioners approved travel requests for Timothy Bechtol and the Treasurer. They also signed the letter to the Ohio EPA for the monthly Explosive Gas Monitoring report ending March 29, 2017 and the fund report from the Auditor's office.

Lucinda Land presented the following resolutions for consideration:

Resolution #180-17 — Authorizing the contract with Jim Bumen Construction Company dba Scioto Valley Precast, Chillicothe, Ohio for the HAN TR 127 1.24 Box Culvert Project in Blanchard Township, Hancock County, Ohio. The total contract amount is \$30,706.00. Brian Robertson made the motion to approve, Timothy Bechtol seconded. Motion passed 3-0.

Chris Long reported what his guys were working on today.

Steve Wilson said that the Pirates Cove demolition is complete and thanked the Engineers office for their help. He also said they started tearing down houses on Washington Street (210, 212, 214) yesterday and should be done by the end of the week or early next week. Steve said the Conservancy District received a call from a local resident asking about construction equipment along the river near the Liberty Street dam. He said that equipment is the City of Findlay. They are constructing a trunk sewer from the north side to the south side in that area and it is nothing to do with our project.
