Judge Routson provided the following updates:

CCA Grant Business/Year End Fund Requests

Director of Court Services/Chief Probation Officer Kim Switzer provided the following updates:

- Managing the Grants Thanks to Julie Smith, Fiscal Manager, Chad McClain for assisting with completion of the graphs.
- Hancock County Adult Probation will be hosting a local ORAS training. It will be hosted in Findlay with CCA grant funds.
- Included in the information packet is the 4th quarter financial report for all three CCA grants. Unspent funds returned for FY 17:
 - ➢ Jail Diversion \$130.00.
 - Prison Diversion \$80.00
 - \succ PIIG Grant \$0.00.
- Indictment's increased about 20 %. This is a big impact on the system.
- Reductions in CCA Grants projected over next two years of \$100, 00.00 in CCA Grants.
 - ➤ With the Judges and probation staff performance we anticipate 407 & 408 all be restored to 100%.

- Reductions in Drug Court by \$60,000.00.
- PIIG Grant updates: not looking as bleak as what we originally thought, it is a changing target.

Hancock County Common Pleas Drug Court:

Director of Court Services/Chief Probation Officer Kim Switzer provided the following updates:

- House Bill 49 T-Cap (Targeted Community Alternatives to Prison)
 - > Targets Non-Violent/Non-Drug Trafficking/Non-Sex Offender F-5
 - > The Sheriff & Justice Center would receive partial funding for housing inmates
 - Hancock County criminal justice partners have decided to apply for the funding and could receive up to \$322,000.00
 - > One half of the funds could go to the sheriff for housing
 - One half of the funds could go towards supporting our Drug Court Coordinator as we've had no funding to support that position.
 - If we accept this grant money, we are agreeing to divert F-5s from Prison. If we send F-5s that meet the T-Cap criteria between September 2017 June 2018 ODRC will be reimbursed \$72.00 a day for every offender that we send.
 - If we would apply the criteria to this past year 6 to 7 individuals would meet this criterion.
- Judge Starn's Drug Court Certification will occur in September 2017.
- Drug Court has approximately 50% success rate. Lack of IOP services this year may have been a barrier to success.
- Proud of staff at Hancock County Adult Probation with the 20% increase in offenders to serve.
- Judge Routson discussed Drug Court Graduate Issac Ewing indicating it had been a struggle but he graduated with his family being present at the ceremony
- Retired Judge Niemeyer advised he has ideas concerning service projects for the Drug Court Alumni Group.

OLD BUSINESS/UPDATES

Re-Entry Committee

Executive Director of the ADAMHS Board Precia Stuby updates:

- Attached handouts and recommendations reviewed.
- Cindy Orley will be the designated re-entry coordinator. I would like to have this approved with any changes the CCA board may suggest, this will then allow plan to be submitted to ODRC.
- The committee would like to bring additional technology into the community, as this could connect the Jail and the other agencies together to know which agencies the offender receives services.
- Time table the last plan expired in 2015.
- Vote on changes at the next CCA board meeting.

Sales Tax Proposal/Impact on Criminal Justice System:

Commissioner Robertson

- Thanks & appreciation to everyone in the room for doing a wonderful job.
- Resolution was passed on May 23, 2017
- Decision was made to move forward for two ballot initiatives
 - > One quarter of a percent for Flood Mitigation
 - One quarter of a percent for the safety & security of the community for the Jail expansion in conjunction with the Probate Court Building
 - > Already has imposed a quarter percent for current operations. Not an additional tax.

Findlay Municipal Court

Judge Miller provided the following:

- Inmates being housed in Wood, Putnam & Hancock Counties. Population approximately 130 inmates daily.
- Turned away about eleven offenders in the last week from incarceration.
- Struggling with housing & transportation
- Caseloads are increasing from traffic to criminal

Courthouse Security

Judge Routson provided the following:

- Updates on any additional security will depend on the Sales Tax issue
- Estimated costs for Justice Center renovations/expansion 2.8 3 million dollars.
- Review the documents that Precia has provided for us & be ready to approve at the next meeting.
