# CCA REPORT OLD BUSINESS

Chief Probation Officer Kim Switzer provided the following updates:

- •CCA FY 17 Annual Report see attached
  - Available on Courts Web Site under Community Corrections Board
  - Reason people are failing the programs
  - Struggle in Drug Court for successful completions. Successful completions comparable with National averages
  - Have kept defendants on probation after leaving Drug Court for accountability
- •Re-cap on Annual Audit with State of Ohio are now very pertinent to our funding 35% of what we are doing to Supervise 700 Felony Offenders are coming from the County funds, the remainder of services are funded by State of Ohio grants
- •IOP substance abuse treatment is now operational
- •FY 18 Allocations reduced were restored
- Received reductions of every State grant they were cut by 20%, now all Grants have been restored

#### **NEW BUSINESS**

- •Satisfaction Survey you should be receiving this thru Survey Monkey
- Revised Board Resolution to Prosecutor's Office
- Quarterly reports for all State grants see attached
- •JRIG formerly known as PIG Grant Grant since 2012 Justice Reinvestment and Incentive Grant still providing funding for two Probation Officers & 1 support staff member. PIG Grant will fade out at the end of this year
- •T-Cap Enhancing & enticing to keep low felony offenders in the local jails
- •Grant monies received about \$322,000 for a 2-year period
- •Agreed with Sheriff & Ryan to give them up to ½ of that amount to offset the cost that it takes to house Felony 4 & 5 inmates that can no longer to Prison. Currently with people that have been sent to prison we have \$315,000 of those grant dollars that would be split with the Sheriff's Department, which would be \$157,000.
- •Being charged \$72.00 per day while in prison
- •Judge Starn waiting on how Court of Appeals will deal with it, it's currently written that participation is mandatory for the 10 largest counties in the State and optional for other 78 counties, additional discussion still going on.
- •Judge Miller asked if the Attorney General approved language to amend the constitution now they are getting signatures to force TCap
- •Judge Starn believes there is a proposed amendment but not TCap being circulated for November ballot, as they want to constitutionally prohibit current Felony 4 & 5 Drug Possession Offense can no longer be designated as a felony effectively making them all misdemeanors. Also believes to include language stating if currently in prison for one of offenses you are entitled to be taken out of prison and have the conviction changed.
- Precia Stuby asked if this is just in Ohio or other states being affected. Judge Starn stated he wasn't sure about the other states.
- •Kim Switzer Sheriff and Commissioners decided to do, still going to send those that belong & deserve prison, to prison and we will take that \$72.00 a day cost and will work the others.

## **Hancock County Common Pleas Drug Court**

- Drug court
  - Participants continue to struggle after they graduate, current success rate would be approximately 50% engaged after completing Drug Court
- •Century Health Forensic Team; Potential merger- no report

- Program Activity
- •Welcoming Recovery Community here in Findlay. We don't have the warmest & welcoming Recovery Community, seems isolated. Would like to get more people involved in Stage 4 of Drug Court. Looking for sponsors that would like to come to Drug Court & become a part of the offenders recovery process.

- Precia stated she believes it should be established in Findlay Municipal Court & Tiffin/Fostoria Municipal Court
- Ret. Judge Niemeyer stated if a change was going to be made it's actually read Fostoria/Tiffin Municipal Court

- Precia stated she would make the change, item #4 to state Drug Court in Findlay Municipal Court
- •Judge Starn with changes is there a motion to approve. Leah Cole made motion, seconded by Kim Switzer
- •Amendment change to March 2018 in title
- Motion to approve updated Re-Entry plan was approved by board

## Job & Family Services

Diana Hoover

- Human Services Levy for the May Ballot Issue #7, as they are currently in crisis for Child Protection & Adult Protective Services
- •Case loads went from in 2014 investigated 94 reports, in 2017 investigated 225 reports; increase due mostly due to people being victimized thru substance abuse issues
- •Child Welfare has been affected as currently 53 kids in orphan care with at least 10 of them not having even one parents to care for them. Also had 91 kids came in & out of care in 2017.
- •Cost have increased 56% from 2015-2017 which is leaving child protective services in crisis mode.
- •Ohio is ranked #1 in Opiate deaths and Ohio is 50<sup>th</sup> in the nation in what is invested by the State into Child Welfare
- •52% of the budget comes from local funding. Have asked Commissioners for 1.7 million dollar placement budget with \$900,000 needing to come directly from the County.
- •Judge Starn asked if she was looking for the Board to take a position & Diana Hoover stated yes motion from Diana Hoover- seconded by Leah Cole to adopt a Resolution for Issue 7. Motion adopted

#### •Legislative Update: Marcy's Law; see attached

Pros Phil Riegle

- •Kim Switzer asked with you as the Prosecutors, will you help define who those victims are so we would know who to do an impact statement for the Courts as well as for any restitution owed. Phil Riegle stated yes.
- Patrick Brzozka asked if your office is informing them about fines so that they have access to this information. Phil Riegle stated we give them a full packet at the beginning, at least half the time we don't hear anything back from them
- •Judge Starn most of this is what we are currently doing at this time
- Pros Phil Riegle states that we still continue to see a large amount of methamphetamine in the community. Most of the methamphetamine that is in the community is high quality from Mexico
- Prosecutor Riegle provided overview of Marcy's Law
