## Special Test Accommodations

Special accommodations for testing can be requested if arrangements are made prior to the date of test. These requests must be submitted in writing to the National Restaurant Association for approval. A request does not guarantee an approval. Please contact this office immediately if special accommodations will be needed.



## Cancellation and Refund Policy

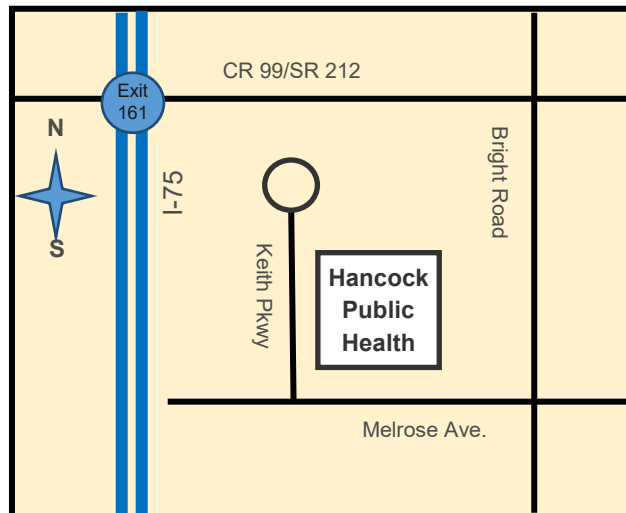
